Initial _____ Sec. 118-46. - Refund of deposit.

Any deposit made to the city by any applicant shall be held by the city until such applicant's utility service for which the deposit was made shall be terminated. Upon termination of such service, the applicant shall be entitled to a refund of such deposit, less any amount due and owing to the city.

Initial _____ Sec. 118-48. - Effect of failure to receive bill.

Failure of any user of any utility service furnished by the city to receive a bill for such utility service shall be no excuse for nonpayment.

Initial _____ Sec. 118-85. - Tampering.

It shall be unlawful for any person, other than a duly authorized employee of the city, to tamper with any meter; or to in any manner injure any meter; or to manipulate or attempt to manipulate any meter in any manner so as to affect its registration or measurement of the metered utility service.

Initial _____ Sec. 118-86. - Procedure when a meter cannot be read.

If a meter reader is, in the opinion of the city water department, unable to procure a reading of a meter owing to the building's being locked or vacant or the occupant not permitting entrance, or entrance to the premises is made precarious by a vicious dog or otherwise, or easy access to the meter is obstructed in any manner whatsoever, the charges may be estimated for the amount not to exceed double the normal charge. If the consumer does not remedy the condition and should refuse further pay the estimated bill, the city water department shall have the right to discontinue the service without further notice and service shall not be resumed until the conditions complained of have been remedied and all charges for water service paid.
